CLERK'S REPORT:

Clerk Mulder-Paul gave a bill listing of \$12,742.84. TREASURER'S REPORT;

Treasurer Munn gave an accounting to the board of the Wakeshma Township's bank balances. They were as follows: Tax Checking;-\$97,750.52; Trust and Agency-\$614.25; General Savings-\$5,715.81 and General Checking-\$16,669.33. Clerk Mulder-Paul moved that the Treasurer's report be accepted as printed and the motion was supported by Trustee Thole. Voice vote, passed.

CORRESPONDENCE:

No correspondence or contract from Enbridge Energy has been received to date concerning the public rights-of-way pipeline project.

ZONING ENFORCEMENT/ORDINANCE REPORT

Supervisor Deming reported to the Board that an agreement had been reached between the property owners at 13985 South 42nd St, 14037 East W Ave and 14029 East W Ave. A letter will be forthcoming to the property owners restating the agreements and time lines of the January 30, 2013 meeting.

FIRE AUTHORITY UPDATE:

As discussed at prior budget meetings, the South Kalamazoo County Fire Authority will be raising its fire protection service contract fee for 2013-2014 to \$48,593.64. A motion to accept the fire protection contract was made by Clerk Mulder-Paul and was supported by Treasurer Munn. Voice vote, passed.

A motion to suspend normal township business was made by Supervisor Deming and was supported by Treasurer Munn at 7:45 pm.

Danna Downing of South County Community Services gave the board a presentation of SCCS' many programs that aid and assist the residents of Wakeshma Township. Of note,
